Reasons for Submission

- A. Our family has been farming in the district since 1800 and we have close family ties to the community in which we operate. Our first farm in the Waimakariri was purchased in 1977 and the farm in Paragraph 1 was purchase in 2005.
- B. We have children and grandchildren that live in the Waimakariri District, that should have the opportunity in the future to choose to have a career in farming or related industries and live in a thriving and stable community for future generations.
- C. The collective value of the land holding, buildings and contracting operations come with long term investments. We have always invested in building equipment, soil quality and with focus on animal welfare.

Particulars of Request and Basis of Submission

- 1. My submissions primarily relate to concerns arising from:
 - 1.1. Policy / Section 8.4.25 8.4.29: Oppose
 - 1.2. Policy / Section 8.5.21 to 8.5.29: Oppose
 - 1.3. Nutrient management provisions contained and reflected in Table 8 and 9 of the Plan: Oppose
- 2. It is generally submitted:

Submission 1

2.1. Timeframes are unachievable, reductions post 2040 go beyond the point of farm sustainability. By 2030 there will be a lot more science, data collection, technology on environmental outcomes. With these developments and the review we will have a more information to make recommendations beyond 2040.

Submission 2

2.2. The reductions set out in Table 8 to 9 are not achievable and will have severe implications for farming in these nitrate priority sub-areas.

Submission 3

2.3 The reductions regime fails to take into account the significant reductions that may be required even to reach Baseline GMP Loss Rate. Highlight that there is much uncertainty around the starting point for nutrient reductions (GMP baseline) due to the current issues with the Farm Portal and overseer they don't align.

Submission 4

2.4 There is uncertainty around the current science due to a lack of data – I have concerns in the modelled outcomes. Due to this; there are also significant concerns with the measured versus modelled data – some areas correlate well but for a number of others they appear to be an order of magnitude out.

Submission 5

2.3. Ground water allocation zone / depleting ground water take. There is uncertainty in the modelling. We have general concerns with the measure data models leading to prediction of nitrates that PC7 is proposing.

Economic and Financial Implications

- 3. A concern if PC7 in its current state it will have an negative effect of the economy for the Waimakariri District and surrounding areas. The flow on effect could be catastrophic.
- 4. The family plays a large role in the Waimakariri community and is a member of the Waimakariri Irrigation Limited Scheme, Next Generation Farmers Trust, Federated Farmers, DairyNZ.
- 5. We are good custodians of the land for many decades working in partnership with ECan. Consequently, it is grossly unfair to now fundamentally change the regime now being proposed by the Plan without allowing a more studied, iterative approach to nitrate reductions.
