Submission

I strongly oppose 14.5.17 point 7 There is no evidence to back up the High Runoff Risk Zone so to lump this non diarying area with the tightest rules in Canterbury

i.e a 20 hectare winter feed limit rather than the 50 or 10% rule available in the rest of Canterbury is not consistant with the outcomes suggested by GMP on a farm by farm basis

14.5.17

The use of land for a farming activity on a property greater than 10 hectares in area is a permitted activity provided the following conditions are met:

1. The property is registered in the Farm Portal by 20 July 2022 and information about the farming activity and the property is reviewed and updated by the property owner or their agent, every 36 months thereafter or whenever a material change in the land use associated with the farming activity occurs, or whenever any boundary of the property is changed; and
2. A Management Plan in accordance with Schedule 7A has been prepared and is implemented, and is supplied to the Canterbury Regional Council on request; and
3. Any increase in the area of the property that is irrigated is limited to 10 hectares above that which was irrigated at 20 July 2019 provided that no more than 50 hectares is irrigated in total; and
4. The area of the property used for winter grazing of cattle is less than or equal to:
 - a. 10 hectares for any property less than 100 hectares in area; or
 - b. 10% of the area of the property, for any property between 100 and 1000 hectares in area; or
 - c. 100 hectares, for any property greater than 1000 hectares in area; and
5. For any property that has part of the property located within the Rock Art Management Area, there is no irrigation on the part of the property within the management area; and
6. For any property that has part of the property located within the Mātaatiai Protection Zone and that includes or directly adjoins any river or coastal lake, there is no irrigation or winter grazing on any part of the property within the protection zone; and

7. For any property greater than 20 hectares in area that has part of the property located within the High Runoff Risk Phosphorus Zone, the area used for winter grazing of cattle or deer does not exceed 20 hectares.

Submission

I oppose plan change 7 B 14.5.7 Part of property in HRRPZ because it puts an unduley onerouse rule on a group of dryland farmers predominately sheep and beef.

The scientific advice of p run off in the zone is all modeled and infact the p levels are very low and showing no signs of elevating GMP will be the best avenue to follow and bring it into line with the rest of Canterbury Up to 15% reduction can be imediately gained through GMP. The reduction of winter feed to 20 hectares in this dryland SouthCanterbury climate with long winters will not be a mitigation of recent development but will be a cruel blow to farming practices over 100 years old and still the water from these farms is of very good quality. The fact that under this proposel if a farm has only a small amount of HRRPZ on their property the whole property is captured.This is unfair,has huge economic cost to per hectare low cost, low nutrient input farms in a challenging enviroment.The average cost per farm for compliance documentation and monitoring is \$14000 over 10 years and thaths not taking into to account the spend on riparian fencing at \$ 12 a metre plus planting.

We don't have many other options for farming on this area and even forestry is a restricted practice because of so called flow sensitive rivers.

South Canterebrus economy is very reliant on a strong agriculture sector and analysis of Plan Change 7 for GDP by LWP makes very sobering reading for this community.The lumping of all the orange zone into the red zone for only practical reasons is a very poor reflection of the work that has supposed to have been done on this plan

And replace with10 hectares for any property less than 100 hectares

10% of the area for any property between 100 and 1000 hectares

100 hectares for any propert greater than 1000 hectares in area
