### **Point 68.1**

#### **Submission**

The plan does not go far enough to remedy nitrate pollution and over allocation of water resource.

Further, it does not address the need for a fairer and more equitable allocation of water. Currently resource is allocated on a "first in" consent basis. Given water is a finite resource, a process towards fairer redistribution of a reduced resource needs to be included in the plan.

Transfer of consent needs to be better addressed.

#### **Relief sought**

Further reduce the allowable nitrate discharges. The plan does not go far enough

Reduce the allowable water allocation. The plan does not go far enough

Add a fair process to redistribute water allocation, rather than first in consent holder.

Add a process to buy-back /or reduce consent allocation within the consent term.

Remove the ability to transfer consents for he approved consent use to other uses

Add the ability to modify consent allocations and other conditions on sale or transfer or the consented property and/or business
