We understand that your examination was conducted in accordance with the Auditing Standards issued by the Auditor-General, which incorporate the International Standards on Auditing (New Zealand). We also understand that your examination was (to the extent that you deemed appropriate) for the objective of providing an independent opinion on the Regional Council's Summary Annual Report.

Responsibilities for the Summary Annual Report

We confirm, to the best of our knowledge and belief:

- we have fulfilled our responsibilities for preparing and presenting the Summary Annual Report as required by the Local Government Act 2002 and PBE FRS 43: *Summary Financial Statements* and, in particular, that:
 - the Summary Annual Report complies with PBE FRS 43: *Summary Financial Statements*;
 - the information contained in the Summary Annual Report is consistent with the full financial statements from which it is derived; and
 - the information contained in the Summary Annual Report represents, fairly and consistently, the information regarding the major matters dealt with in the annual report; and

 we are unable to provide you with documentation to support the MetroCard revenue-inadvance balance to the amount of \$2,510,546, and we are unable to quantity the financial amount of expired MetroCard values that should be released to the statement of comprehensive revenue and expense.
