9. Nature Agents - 22 August 2019

Committee Comment

- 1. A presentation was given by Kirsty Brennan, EOS Ecology, and students of Ilam Primary School about Nature Agents of Change. Issues Nature Agents are dealing with relate to the lack of effective science programmes within primary schools. The approach Nature Agents is implementing relates to science, captivation, and collaboration to be end-user appropriate. The Nature Agents programme includes an equipment kit, printed and digital resources and field sessions with scientists.
- 2. The Ilam Primary School students reported on their activities, including learning to take water clarity measurements, holding a parent open night, and presenting their information to the School Board. The outcomes they are seeking are for children to be able to swim in the Avon River, and to be part of the solution of having clean rivers throughout New Zealand.
- 3. The students noted the following help that the Zone Committee could give to Nature Agents:
 - a. Come along to our 'Nature Agents' field visits and see what we do!

- b. Provide opportunities for schools to present their results/findings/ideas for action.
- c. Funding transport for schools to attend Botanic Gardens event for Operation River Quest.
- d. Funding 'Operation River Quest' Report Card providing evidence, set improvement benchmarks and raise community awareness.
- e. Funding St James School 'Nature Agents' transport to their site.

4. Deputations by Appointment

4.1 Drinkable Rivers.NZ

Michael Mayell spoke on behalf of Drinkable Rivers.NZ about restoring New Zealand's greatest assets, its rivers, to natural beauty and reconnecting with the natural world. Christchurch has the opportunity to become the epicentre of change, provide transparent feedback from the rivers with a community led movement for education, resources and connections, and to work together to make waterways swimmable and drinkable. He advised that the focus for Drinkable Rivers.NZ was starting with 110 metres at the head of the Ōtakaro/Avon River.

Michael reported on the following:

- 1. The first real time data sensor currently being calibrated is the Oracle 1.
- 2. Options are being explored to extend the dataset and to use data for the most complete dataset.
- 3. Education is important to help share vital information and for practical resources.
- 4. Community engagement need to support all New Zealand existing water champions, support planting events.
- 5. Note that 22 September is world rivers day that DrinkableRivers.NZ will be involved in.

Michael advised that DrinkableRivers.NZ was looking for a landscape architect to develop a planting plan for the reserve and all rivers. We need help from everyone.

- Tami reported on other items noted in her report, including World Rivers Day on
 September, an opportunity to have a Stormwater Superheroes presence at the Ōpāwaho Heathcote River Network Annual World Rivers Day event.
- 3. Tami reported on the work programme for the rest of 2019 that had been formed following a Zone Committee workshop, that would include water quality in September; Port Hills in October; and Industry Stormwater rewards in November.
- 4. Les Wanhalla thanked members of the Zone Committee for attending and being part of the recent Selwyn-Waihora Zone Committee meeting to discuss urban issues. He advised that the Selwyn-Waihora Committee would be giving more consideration to urban issues.
- 5. Tami noted that the quarterly report to Christchurch City Council from the Committee had been received earlier in the day. The Mayor had advised that the Committee's letter had been used by CCC as part of their advocacy to the Ministry of Health (MOH) and the Mayor noted that MOH had a Chief Scientist charged with looking into the issue, Ian Towns.
- 6. Gareth suggested a briefing for the Zone Committee on wastewater overflows and how frequently they occur, targets etc.
