Andrew, West Coast Road is State Highway 73. There are a conglomerate of quarries on West Coast /Old West Coast and Miners Rd block.. Road Metals Ltd have an access onto SH73 with an at grade right turn bay and left in de-acceleration bay.

Fulton Hogan Ltd are on both sides of Miners Rd with key access onto Miners Road and no access onto West Coast Road.

There are two more quarries on Miners Rd with access onto Miners Rd.

**Fletcher Concrete ( Winstone Aggregates) have a quarry on Miners Rd with access onto Miners Rd and address at 233 OLD WEST COAST Rd. I presume that is who you mean. They also have access onto Old West Coast Rd , the quarry name is Yaldhurst Quarry. They have an RMA application in 2018, for additional vehicle movements. Emma Chapman handled the application.**

**Winstones have two access points on OLD West Coast road. The eastern one is for truck ENTRY only, and the western access for all movements light vehicles only. The loaded trucks EXIT onto Miners Rd left out only and then use Miners/ SH 73 for vehicle movements. In effect loaded trucks are therefore avoiding Old West Coast Rd.**

Mike Calvert has been handling the Roydon Quarry application but is on leave and Tim Wright QTP has been giving evidence on Councils behalf.

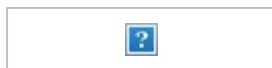
