# **Purpose**

 To appoint a Hearing Commissioners to hear and decide an objection to costs of processing of a resource consent application CRC193716 applied for by Leamington Downs Limited.

### Recommendations

That the Regulation Hearing Committee in regard to an objection to costs incurred in processing of the application for resource consent CRC193716 applied for by Leamington Downs Limited:

- 1. Appoints Sharon McGarry as a Hearings Commissioner under s34A of the Resource Management Act 1991; and

# **Background**

2. Learnington Downs Limited has objected to the cost of processing of application CRC193716 to discharge contaminants and odour to air from an intensive poultry farm at Stockgrove Road, Glasnevin. The application has been notified with submitters to be heard. A hearing has yet to be heard for this application.

# **Proposed Commissioners**

 Mr Ken Lawn was appointed on 23<sup>rd</sup> July 2020 to hear and decide this objection hearing. Mr Lawn has subsequently declared a conflict of interest and is unable to hear the objection.

- 4. It is proposed to appoint Ms Sharon McGarry to hear this objection. She is an experienced independent hearing commissioner including chair positions in both small or large hearings.
- 5. For this cost objection hearing staff have assessed whether other Hearing Commissioners might be available, on the basis of no conflict of interest, availability to hear and make a decision and suitable experience in understanding and evaluating the key issues. The Hearing Commissioner recommended to the Committee is considered to be the most appropriate, having taken those other matters into account
- 6. Sharon McGarry has satisfied Council staff she has the necessary criteria, including technical ability, availability, timeframe commitments and RMA Accreditation certification to carry out the duties required.

- 7. S34A of the Resource Management Act 1991 allows Council to delegate functions to Hearing Commissioners appointed by the Canterbury Regional Council.

### **Purpose**

1. To appoint a Hearing Commissioner to facilitate a pre-hearing meeting.

### Recommendations

That the Regulation Hearing Committee in regard to resource consent application(s) CRC204346, CRC204347, CRC204348, CRC204349 and CRC204350 applied for Fulton Hogan Limited:

- 1. Appoints Ken Gimblett as a Facilitator under s99 of the Resource Management Act 1991.
- 2. Delegates to Ken Gimblett pursuant to s34A(1) Resource Management Act 1991, the function, powers and duties required under s99 to facilitate a prehearing meeting.

# **Background**

- 1. Fulton Hogan Limited has applied for resource consents to extend the existing Fulton Hogan quarry operation at 552, 562, 572 and 582 West Coast Road and 52, 68, 80 and 92 Kettlewell Drive, Yaldhurst.
- The proposal includes the excavation of land (extraction), the deposition of material into land (cleanfilling), the discharge of dust to air, the discharge of contaminants from cleanfilling onto and into land where they may enter water, and to take and use water. Crushing, screening and stockpilling of excavated material within the extension is not proposed.
- 3. Consent applications include change of conditions of existing consents to take and use water; and discharge contaminants to air; and new applications to use land for quarrying; discharge contaminants from cleanfilling onto and into land; and discharge contaminants to land.

- 4. The applications were limited notified. Four submissions have been received with three submitters to be heard. The submissions, in opposition, indicate concern about adverse effects including noise; air quality, dust; water contamination; lack of consultation, visual impacts; health and traffic.
- 5. The applicant has requested a formal pre-hearing meeting which is for the purpose of clarifying a matter or issue; or facilitating a resolution of a matter or issue.
- 6. A pre-hearing meeting is to be held prior to a hearing.

# **Proposed Facilitator**

- 7. It is proposed to appoint Ken Gimblett as Facilitator.
- 8. We sought a facilitator that has experience in facilitating meetings and enables open and robust discussion between parties.
- 9. Mr Gimblett is an experienced facilitator and hearing commissioner in either a sole capacity, or as a panel member. He is also a trainer for the Good Decision-makers Ministry for the Environment programme.
- 10. For this pre-hearing meeting staff have assessed whether facilitators might be available, on the basis of suitable experience to achieve resolution wherever possible between an applicant and submitters, availability to facilitate a meeting and no conflict of interest. The Facilitator recommended to the Committee is considered to be the most appropriate, having taken those other matters into account.
- 11. Ken Gimblett has satisfied Council staff he has the necessary criteria, including technical ability, RMA Accreditation certification, availability and timeframe commitments to carry out the duties required.

- 12. S34A of the Resource Management Act 1991 allows Council to delegate functions to Hearing Commissioners appointed by the Canterbury Regional Council.
- 13. The Regulation Hearing Committee appoints Hearing Commissioners in relation to consent authority matters under the Resource Management Act 1991.
