Reasons comment:

As a Coalgate resident - we have seen at night the mines lights against the skyline, and on many a quiet summer night outside, we can hear the machinery. On some days when we go along the Bluff hill walk on the ridge, 5 mins away from where we live, we can see the dust up near the site. We described this, So that this can give you an indication of our distance from this mine site. And the minimum effects we currently have. Understanding that the owners desire to request an expansion of this mine, we are aware these minimum effects will only increase. Reason 1.) Further enlargement of this Mine, will effect our Air Pollution. Our Breathing and dust settlement - increase particularly on the days with Norewest winds. (Considering also the mine is higher up then the Glentunnel and Coalgate townships, established further out and bellow.) Reason 2.) Expansion of this mine, will inevitably effect underwater supplies. That work their way down toward our townships. Effects such as Contamination to future water sources. We already have an issue with getting enough water out in these areas. Let alone keeping it clean water. Reason 3.) Night noise: As the Townships Coalgate and Glentunnel (5min drive round the corner), are lower then the Mine further up the hills, the noise travels on still nights. Increased expantion to the mine will inevitably mean increased machinery and workers. = Increased noise. Reason 4.) In relation to the above listed - values to our Township residential properties could well be effected long term for the worse.

Stop all of the above effects that will happen with this mine being developed much larger. NO - To allowing an Open Cast Coal Mine NO - To any further Expansion development Due also to the

resent Fine this company incurred, future risks of this kind, would always be a possible LIABILITY to our Townships Coalgate and Glentunnel.
