

**Temporary Reservation Certificate, issued pursuant to:
Canterbury Regional Council Navigation Safety Bylaw 2016
Clauses 12 and 32.**

Name of holder: Little Rakaia Boating Club Inc
Period: From: 0800 to 1600 Saturday 6 th March 2021 and Sunday 7 th March 2021 or reserve days of Saturday 27 th March and Sunday 28 th March 2021. Until revoked by the Harbourmaster.
Reserved Area: Rakaia Lagoon to the North of the boat ramp in the 5-knot restricted area.
Map attached: No
Purpose: Uplifting of 5 knot speed limit in the case of the Rakaia lagoon, reservation of Rakaia River Lagoon to the south of the lagoon to the river mouth so no other vessels are on the course for navigation safety reasons.
Reservation: <ul style="list-style-type: none">• The Reserved Area for the Rakaia Lagoon is declared by the Harbourmaster to temporarily a SUZ for the stated period only. No vessel shall navigate within the Reserved Area except vessels under the control of a full member of Little Rakaia Boating Club Inc; and are properly marked in accordance with the Bylaw; and with the permission of, and in a manner approved by, the certificate holder; and in accordance with the terms and conditions stated on this certificate.• No other vessel shall navigate within the Reserved Area as delineated on the maps attached, except vessels under the control of a full member of Little Rakaia Boating Club Inc; and are properly marked in accordance with the Bylaw; and with the permission of, and in a manner approved by, the certificate holder; and in accordance with the terms and conditions stated on this certificate.
Conditions:
Publication of notice of Reservation: Notification to known affected groups; notifications on appropriate websites and social media; notices at known boat ramps and key access points. At least 14 days prior to the race day.
Notice of Reservation to be: Displayed at: As above. Displayed by: LRBC Inc Representative (or delegate). Removed by: LRBC Inc Representative (or delegate).
A copy of the Temporary Reservation Certificate to be carried by: Race organiser or delegated person
Safety conditions: <ol style="list-style-type: none">1. Every vessel operating under this Temporary Reservation shall do so in compliance with the Bylaw; and all relevant Maritime Rules; and all relevant rules and codes of practice of LRBC Inc.2. Every Vessel operating under this Temporary Reservation shall be made aware of the LRBC Inc Safety SOPs in relation to river use and follow then accordingly. If SOPs have not been prepared LRBC Inc is to prepare a safety plan and advise all persons operating under this temporary reservation of the plans requirements.

3. All competitors are to be advised that whilst the rivers notified in this Temporary Reservation Certificate have been uplifted and reserved for the sole purpose of the races specified , should an unauthorised vessel be on the course, all vessels are immediately to comply with Maritime Transport Act 1994 Rules 91 and 22. 4. Prior to the event the lagoon is to be checked for any hazards natural or otherwise that may impede safety, all drivers and navigators are to be made aware of these hazards.
