There has been no focus on any air quality issues within the Selwyn district. Many areas within Selwyn suffer from severe inversion during winter and as it is not near the coast in many parts does not have the advantage of a sea breeze to disperse any smoke from residential heating. I believe air quality needs to be taken more seriously and targets implemented along with airsheds installed in all townships within Selwyn.

Along with this, there is a severe lack of public transport within the Selwyn district. I feel the district needs a frequent orbiter style bus service that connects the smaller towns with Rolleston (Rolleston is also the location where many of the regions facilities are being built, including health Centre, library etc which unfortunately is unable to be accessed by many in the district due to lack of transport) - by connecting the smaller towns with Rolleston people will be able to take connecting busses into Christchurch on a more frequent basis compared to the current model (1 bus in the morning 1 bus back in the afternoon from Christchurch) which is practically unusable by the majority of people (and is reflected in the low patronidge)
