The overwhelming feature of the city is more and more infrastructure and less and less natural environment. The main 'product' of the council seems to be concrete and tar seal. And almost every new house gets resource consent to cover >51% of the section, and there are more and more motorways. Economic progress that replaces the natural world in the face of impending ecological disaster is set to ruin my children's and grandchildren's lives. When the earth starts to seriously heat up in a few years' time, all that tar seal and concrete is going to make this city intolerably hot. We have not got our thinking caps on yet. We need to be halting use of private cars and making low emission public transport mandatory. Most adults have their heads in the sand over this so I think the council would be better to consult with a bunch of twelve year olds, they'll be a lot more sensible and forward thinking. We also need to urgently find someone to invent a roading and pavement surface that doesn't absorb heat like tar seal does.

Other things:

- 1) The elevated motorway overbridges are very noisy, my once peaceful suburb of Halswell is now constant motorway noise 24/7.
- 2) The overbridge from Halswell to Wigram on Dunbars Rd blocks the view of the sparkling Southern Alps against a blue sky, which was the only view you get living on the flat in Oaklands. I can't be the only person who needs see beauty to feel like there is a reason to get up each day.
- 3) We need our public parks covered in spreading trees, not big open areas of grass. The swimming pool at Halswell needs a decent sized shade sail, sunburn is a melanoma risk. Every public park and pool in Christchurch needs shade too, we need to plant out our parks with spreading trees, it will soon be too hot for kids to play outside if there are no trees to shade them. It's ten degrees cooler in the shade.
- 4) Every NZ city needs a predator-proof bird nursery like Zealandia in Wellington to supply the local area with indigenous birds.
- 5) We need dedicated wetlands and wild spaces for animals to live in peacefully, not doubling as recreational areas for people to jog in and walk their dogs, and thus chase all the animals away. We need to plan to control or restrict cats in Aotearoa. Cats are the natural enemies of our main kinds of indigenous animals.
- 6) We need more park rangers in summer to patrol wilderness spaces eg Port Hills to deter people from setting fires.
- 7) We need to be a lot braver and spend more money on this, like people do in Scandinavia and Germany. Short term thinking and saving a buck is how the world got into this climate change mess in the first place.
- 8) Poor people need to be protected against rates increases and when I say poor people these days that is probably 50% of the population because the rent doubled overnight after the earthquakes, and average and poor families have been on the back foot since. So we need to protect the poor from further housing costs they can't afford.
- 9) Something else will need to be chopped from the public budget, and it is probably something dear to the heart of some sterling public servants who have made big contributions in the past. However, some of the people minimising climate change will not be around to see the suffering it will cause, and others have enough wealth to buffer themselves against its worst effects. So in my opinion our society needs to prioritise our children's and grandchildren's survival over other shorter term considerations.
