**Air Quality, Transport and Urban Development portfolio comments:**

I live in the Selwyn District and believe that as well as the current bus routes, an Orbiter style route would serve the people of Selwyn well. Not everyone living in the Selwyn District wants to go to Hornby or the city.

I would recommend a bus route that includes the townships of Rolleston, Darfield, Lincoln, Springston, Leeston and Prebbleton (and maybe Halswell and/or Hornby), and for the route to be a bit more flexible if necessary.

Frequency is also an issue as currently the bus into the city, via Hornby, only runs every half hour and the trip takes an hour. I sometimes drive to Halswell where the buses run about every 15 minutes and then it's only a 20 minute bus ride into the city on the No 7 bus.

Taking into account the fact that the District is growing at a rapid rate in all of the townships, you might get more passengers on board by travelling the routes they actually wish to travel to.

Also people might be more inclined to use the bus service if there were more bus stops in the growing townships. Currently my nearest bus stop is a 20 minute walk away, so occasionally I drive to the bus stop. Then I think it would just be as easy to drive the rest of the way to my destination!

I really think more people in the Selwyn District would use the buses if they were going to more of the places we want to go. So let's get on board together and travel in the same direction.
