2nd issue- dune restauration and erosion river banks

With sea water level rise and increase flooding risk- the building of new houses in high risk areas/near waterways can be actively discouraged. Also - retreating from waterways can be encouraged. What I currently see is new houses being build in high flood areas like our estuary in South Brighton. I also see barriers- brick structures- at the high tide line of the estuary- being replaced- those barriers only have been put a few years ago- and already destroyed by high tides and flooding.

The natural course of our rivers have to be analyzed. As we do have a space to retreat - it is important to give space for our dunes and natural riverbanks so they can grow instead of erode so they can protect us from flooding and sea water level rise.
