I support Environment Canterbury's Option 1 proposals to "step-change environmental progress" and to "increase activity to accelerate regional outcomes" through its draft Long-Term Plan (LTP). However, the proposed increased investment, particularly in the Water and Land, Biodiversity and Biosecurity is probably insufficient to achieve the regional goals articulated in the various current strategies and plans for land and waters, biodiversity.

Environment Canterbury is a major "landowner" administering public lands along our waterways and should demonstrate best practice public land management. I recommend that the LTP make an investment of \$2.0M in the strategic and prioritised transition of the grazing land-use to healthy

waterways and indigenous biodiversity with stock exclusion and indigenous revegetation of riparian and wetland areas.

Water and Land portfolio comments:

I support Option 1 investments in this portfolio. However, more investment is recommended for Healthy Waterways Actions of \$8.9 M, Working Together for Healthy Land and Water of \$6.0M.

Biodiversity and Biosecurity portfolio comments:

I supports the Option 1 investments and particularly the proposed investment in the Braided River Revival (proposed \$3.8M) and a regionwide tree planting programme (Me Uru Rākau) (proposed \$1.0M) as key programs to restore natural ecosystems and improve biodiversity. However, more investment is required given the scale of the need. I recommend additional funding of Braided River Revival to \$7.0M and Me Uru Rākau to \$5.0M

Climate Change and Community Resilience portfolio comments:

I support Option 1 investments in this Portfolio. However, I recommend reducing the investment in Leading Community Resilience to \$3.5M and Flood and River Resilience to \$11.0M and Managing Coastal Environment to 3.0M. I recommend that the \$3.8M savings in this Portfolio be transferred to Water and Land and Biodiversity and Biosecurity.

I support the proposed Contestable Fund to facilitate community engagement and contribution and recommends a doubling of this investment to \$0.9M. Similarly, I recommend that the allocation of funding for grants to each Zone Committee be doubled to \$0.2M/year.

Air Quality, Transport and Urban Development portfolio comments:

I support Option 2 investments in this Portfolio and recommend a reduction to Transforming Public Transport to \$30.0M. Savings from this reduced investment should be transferred to Water and Land and Biodiversity and Biosecurity.

Regional and Strategic Leadership portfolio comments:

I support Option 2 investments in this Portfolio and recommend a reduction to Engagement and Influence to \$8.0M and Investing in the Future to 1.8M. The saving from this and Option 1 investments should be transferred to Water and Land and Biodiversity and Biosecurity. I support the proposed funding to Enviro-schools.
