The only thing I would like to have seen included in the LTP that wasn't is a plan on how to manage fire risk in the port hills. I am, in full support of the Tuia agreement, the appointment of Tumu

Taiao (mana whenua experts) to Council, and the Youth Ropū. It is vital that we increase truly representative community engagement, and these three initiatives will go a long way in doing so. Maori have long been the guardians of this land - we need to recognize this and begin following the lead of local iwi in moving towards a more sustainable future for all. The council's work with the Youth Ropū

is vital - young people are highly aware of the environmental and resourcing issues faced in todays world, and will be the ones most affected by the decisions that we are making now - their voices must be given a platform.

I fully support the completion and continuation of the MyWay by Metro trail in Timaru, as outlined in option 1.

I fully support the Hekeao Hinds Managed Aquifer Recharge (MAR) infrastructure project, as outlined in option 1.

In many ways, we simply cannot afford NOT to take the actions outlined in Option 1. If we fail to act in a swift and decisive manner now, the cost and impact on future generations will be exponentially higher. The increase in rates is a much needed investment in our future resilience and wellbeing. We need to ensure that ECan receive the funding and support required to carry out the mahi they have been tasked with to a high standard. Engaging the public in a genuine and meaningful way is a costly exercise, in both time and money - but pays off in increased commitment and compliance of stakeholders.

Is there any way that we can try and prevent the rates increase from negatively impacting those who are on low income? I.e. could Ecan suggest to Work and Income that housing cost support for low income families is increased to cover the increase in rates (which will be reflected in rental pricing)? I believe that the question of how to mitigate the comparatively higher impact of the rates increase on low income households deserves more consideration.

Also - I would love to see more subsidized or free public transport services for those who are on low income.
