Air Quality, Transport and Urban Development portfolio comments:

MyWay is an excellent service and our family rely on it. Our 17 year old uses it to travel to study at Ara each day. Our 21 year old with special needs uses regularly it to access opportunities for recreation and socialization. The flexibility of the MyWay bus service has made a big difference to his ability to access the places he wants to go to and has made a big difference to his life and his independence. He will need it to travel to work once he secures a job. The service works very well and is well regarded in Timaru. Timaru needs it to support transport disadvantaged residents such as disabled, elderly and those without their own transport. MyWay sets the standard for future public transport. It is aligned with central government and Ecan's own objectives so should be retained at least. Cutting MyWay in Timaru while investing in passenger transport in Christchurch would be unfair to Timaru residents who have as much right to public transport as Christchurch residents. We have heard some people say they don't use it so don't want to pay for it - do the feel the same about hospitals and libraries?
