My concerns are around private transport, the dominance and priority given to cars and the lack of encouragement given to cycling and walking. I would like to see some of our wide roads narrowed, certain streets become one way, dedicated separate cycle lanes be prioritised and trees planted on these streets.

The current cycleways (white lines one metre apart on busy roads) are insufficient, still dangerous and often driven over. They don't meet my definition of cycle lanes at all and are not used by young cyclists at all (which is sensible as they are far too dangerous).

Done properly we could improve traffic flow, but also reduce traffic and encourage walking and biking/scooters to shops and schools and make Timaru streets modern and beautiful. At present they are wide, grey and priority is given to the car and we need to address this imbalance for emissions, safety, aesthetics and health reasons
