## Water and Land portfolio comments:

I'm concerned about the health of our waterways, especially the impact on human health and biodiversity of excess nitrates due to overstocking & excessive fertiliser use.

I urge ECan to bring in AND enforce regulations to protect waterways and groundwater from excess nitrates.

I support any moves ECan makes towards changing our ways of food production towards greater diversity of farming types, and a return to arable, mixed cropping and sheep/beef farming that is more suited to the dry Canterbury plains.

I urge ECan to prevent the renewal of the big irrigation resource consents that were brought in under the ECan Commissioner regime when the public had no say in how our land and water was used.

### Biodiversity and Biosecurity portfolio comments:

Native bees and flies provide as much if not more pollination for human food production as honeybees but are dwindling fast due to habitat destruction as the city moves out and as farming practice continues to include the annual dousing of farmland with herbicide prior to sowing.

I urge ECan to:

- 1. Bring in and enforce regulations to:
- a) prevent the clearance of wild/'waste' spaces (as well as native bush etc) that provide a habitat for wild pollinators.
- b) reduce the use of herbicide
- 2. Work with Christchurch City Council and district councils to reduce their routine use of herbicide for "tidiness", and work with them to increase corridors of wild diversity throughout the region

### Climate Change and Community Resilience portfolio comments:

I support ECan putting ALL its plans and processes through the lens of climate change and community resilience. I commend the new council for taking seriously its 2019 Declaration of Climate Emergency. I urge ECan to consider specifically how we can boost our local food security, given scientific predictions of global warming speeding up and various tipping points being reached sooner than expected. It seems quite likely that in the next 10-20 years our region will face continual drought and loss of pollinating species. As other countries struggle with the climate/eco crisis, we may well also face severe cuts to trade links/imports and a massive influx of climate refugees.

In such a scenario it is crucial that the population knows its food is secure.

I urge ECan to consider these quite probable scenarios and develop back-up plans accordingly. Eg where is the most productive food-growing land? What works best in drought conditions etc? How will people get access to food if petrol dries up?

I support ECan's plans for climate education. I think it needs to include

- a) education on the importance of maintaining wild biodiversity for our food security as we move deeper into climate instability and ecosystem collapse.
- b) collective and systemic change, not just individual behavioural choices

## Air Quality, Transport and Urban Development portfolio comments:

Urban development and transport planning needs to be considered through the lens of the worst case climate/eco scenario, as above. Each month sees more scientific studies showing that such scenarios are becoming increasingly likely.

### Regional and Strategic Leadership portfolio comments:

I strongly support ECan taking seriously your responsibility as a democratically elected body tasked with protecting this rohe, its taonga and its people.

Local (and central) government need to take the initiative in planning for this. because a free market economy by its nature responds solely to short-term profit for shareholders, and has no responsibility for the collective welfare of the people and the land.

Im aware that ECan is often hamstrung by policy/processes at central government level. I support ECan working with central government where it can, and challlenging and lobbying it where central policies/ processes are hampering what can be done locally, especially in terms of the speed needed to develop community resilience to the climate/eco crisis we are in.

It is crucial as the climate/eco crisis deepens that everyone ubnderstands and supports the collective changes we are likely to have to make. I urge ECan to work in partnership with local iwi to trial forms of participatory democracy, such as citizens assemblies where these fit in with the principles of Te Tririti and with the processes being devloped through the Matike Mai project.
