This submission deals only with the proposed new charge of \$57.50 pa that is intended to be imposed upon swing mooring holders for work undertaken by the harbour masters office involved in the removal of wrecks.

This is in addition to the \$230 annual fee which was imposed against the overwhelming majority of mooring owners wishes and is the highest annual fee of any local body in New Zealand.

By way of example the Marlborough District Council charge \$50.

Firstly I would like to note that the Harbour Master web site contains no reference to this impending change so it follows that there is no supporting evidence or rationale as to how this figure has been arrived at.

It would therefore appear to be a simple increase in the already exorbitant fees already levied. Secondly it is repugnant to natural law whereby the innocent are required to pay for the failings of another.

You may as well charge all vehicle owners for the removal of burnt out cars dumped on a river bank. Thirdly the annual inspection requirement, itself twice what all other areas impose, means that a vessel breaking free from a registered mooring must be a rare occurrence and if it does, then that would qualify as an Act of God for which no one is to blame.

Lastly, the harbour master has on file all the necessary contact details with which to trace the ownership or legal responsibility for any vessel using a registered mooring so it must be a simple matter to recover these costs either from the owner or their insurer.

It is unjust and inequitable to coerce those mooring owners who are meeting all their obligations to have to pay for either the negligence of another or a simple accidental event.

To impose this charge would be unlawful.
