One way of accomplishing this is to stop flood protection within a reasonable distance of a braided river. It is a huge part of ECAN's budget and I am concerned at how much is spent in reestabliishing paddocks that were originally part of the river and taken into private ownership by stealth. I want ECAN to prioritise the environment over

all business interests and I want ECAN to prioritise public interests over private interests. I want the use of Commissioners to make important political decisions stopped. Where is a commissioners accountability? And to who? It is very undemocratic and clearly a mechanism for making decisions that are unpopular.

### Water and Land portfolio comments:

I am very concerned about the issue of Nitrates in fresh water. This is an issue that is particularly relevant to Canterbury because of our gravel soil and the huge expansion of Industrial agriculture within Canterbury in the last 2 decades. I want the nitrate polluters to pay heavily if they fail to address these issues. I want ECAN to establish rules that cut the number of cows allowed on our soils. I am concerned that farmers are being blamed when they are just doing what good businessmen do..... optimize their profits, when it is the Government agencies and ECAN who are failing to set rules and boundaries and enforce them. In fact, responsible farmers will be expected to compete unfairly with their neighbours who ignore the rules. The Time for softly softly and education is bloody over!

## **Biodiversity and Biosecurity portfolio comments:**

Like the rest of the world, our biodiversity is under threat from development and imported pests. I would like driving banned from the beaches and four wheel drives banned from river beds. I would like all cats to have the same restrictions as dogs, ie, registered and chipped, with a limited number per household. I understand this is the City council but ECAN needs to protect our native species. I am supportive of the plans as proposed.
