I have used the MyWay service and found it great on the whole.
Unfortunately I can no longer use it because of my progressive disability.
I am a Senior citizen and Sight Impaired but previously could manage to get on and off the vehicle while using my walking stick..
I have since had an accident and now use a walking frame.
This means that I can no longer manage getting on and off the vehicle as my balance is very poor and I can't take both hands off the frame to fold it and load it on to the bus at the same time or I fall over.
I cannot risk another fall.
If it was possible for a driver, or another person, to be able to help those people tagged Mobility, I would then be able to use the service again.
Mothers with babies and buggies and perhaps a toddler in tow will also be disadvantaged.
Bus drivers in days gone by always used to lift prams and pushchairs on to racks on the front of buses but this doesn't seem to be the case now.
I have no problem paying extra on our rates for this service.
I hope that this will be taken in to consideration when deciding on the viability of the MyWay service.
I will not use the old style bus service should that be the final option.
