Water and Land portfolio comments:

The large amount of stress in the rural Canterbury sector and uncertainity around water for the farming community and service towns and businesses.

There needs to be more water storage e.g. raise Lake Coleridge level and Lees Valley formation of lake there, to secure future generations of Cantabrian's livelihoods and water supply.

Air Quality, Transport and Urban Development portfolio comments:

Air quality has improved with Council clean air policies.

Canterbury has a relative lower density population spread over wide land area. Places of work are not centralised. Therefore I have doubts over buses ever being the one-size-fits-all solution. The new northern and southern motorways have led to a good outcome to shift commuters in & out of the city, though there is congestion where double lanes merge to single lane in the city centre.

Regional and Strategic Leadership portfolio comments:

Lack of skilled leadership. It seems this is from theory based knowledge rather than hands-on experience e.g. computer modelling rather than talking with people on the ground.
