I think the public transport needs to be revisited. As a regular bus user it was very disappointing to see that the timetables have been changed so that buses do not come as frequently during the busy times of the morning and evening. While I appreciate that bus numbers dropped during COVID (very understandable given we have experienced a global pandemic) you will not increase the number of bus users by reducing the frequency of trips during the busiest times of the day. The one thing that will encourage bus use is if it is quicker and more convenient than using your car. But if the time between buses is too long people simply won't see taking the bus as a convenient option.
