#### Water and Land portfolio comments:

1. Support fast-tracking the creation of management plans for each of the braided rivers from source to sea.

2. The protection and restoration of wetlands must continue to be a high priority with adequate funding.

3. Please ensure terrestrial and water ecologists are part of the decision making on braided rivers and wetlands - this is the only way that what is produced has credibility and will have the environmental outcomes sort.

4. Support the Coastal Plan Review - this is urgent - our oceans continue to decline.

5. Fund highly effective community groups such as the Avon Heathcote Ihutai Estuary Trust. This trust delivers on many of ECan's work streams such as educating the public on how to protect the estuary, funding research on estuary ecosystems and the impact of human activity on estuary bird life.

#### **Biodiversity and Biosecurity portfolio comments:**

1. Protect what remains. Tilt the balance in the budget from planting to protecting what remains of our biodiversity. Use strategies such as fencing, pest control and land purchases with high biodiversity values

2. Fund the Trusts that are more able and agile to do this such as the Banks Peninsula Conservation Trust and the Rod Donald Banks Peninsula Trust. Two highly efficient and effective organisations delivering on ECan's vision for biodiversity.

3. Support the continued funding for Pest Free Banks Peninsula - this is a model of how communities have come together to tackle a problem. However, the scope of Pest Free means that new invasions such as pigs found in Kaituna Valley are not covered so additional funding strand is needed to be agile for such events

4. Research has shown that wasps are increasingly impacting on native invertebrate species - part of our native ecosystem food chain is collapsing. Request that wasps are added to the biosecurity portfolio

#### Climate Change and Community Resilience portfolio comments:

Support all work in this portfolio. Support ECan demonstrating what it is doing for reversing climate change impacts. Support mitigation such as its work in preventing soil loss, promoting carbon sequestration through regeneration of native forests, increasing the number of regional parks and farmers' efforts to protect wetlands and the braided rivers a farm may adjoin.

#### Air Quality, Transport and Urban Development portfolio comments:

- 1. Support the continued focus on improving air quality in all centres
- 2. Support on- demand transport in Timaru

3. Support working towards electric bus services and rapid transport solutions and dedicated bus lanes

4. Urban Development. Creating liveable cities: 15 minutes walk to all services including parks. Neighbourhoods that provide active ways of getting around such as footpaths and off road cycleways must be at the forefront of urban planning decisions in the Greater Christchurch Partnership

#### Regional and Strategic Leadership portfolio comments:

1. Support partnership with Ngai Tahu and Tuia programme within ECan

2. Support increasing funding for EnviroSchools - educating the next generation is the key to the future

well-being of the planet

3. Support funding for Youth Forum and all work with young people

4. Support the development of instruments to gather robust data on which to make decisions. Biodiversity data will be an essential part of this to determine if actions are improving outcomes for biodiversity or not

4. I support ECan to be a leader in protecting and restoring healthy natural ecosystems and encouraging not just good agricultural practices but regenerative ones.
