This Long term plan seems to go beyond the remit of Ecan under the local body act. Fiscally irresponsible to load all projects on this plan with no thought to how it will be affordable and of benefit to all communities without huge increases in rates at a time when these are not affordable. Ecan need

to ensure that their base remit is flood protection, biosecurity, biodiversity and water resource management.

Water and Land portfolio comments:

Ecan has already encouraged the communities to improve their management on farm (through FEP), efficencies' through bucket tests, targeted irrigation, reduction in synthetic Nitrogen, targeted baselines, if these are not good enough why did ECAN develop them in the first place if you don't have faith in them. The essential fresh water is a national strategy with a one size fits all approach which doesn't necessarily fit within all catchments.

Biodiversity and Biosecurity portfolio comments:

Essential fresh water does not wholly support wetland restoration, all new consents rural and urban should have an environment plan in place, this doesn't seem to fit within the efw for urban sectors, WHY NOT?

Climate Change and Community Resilience portfolio comments:

Limited impact on urban areas, development doesn't seem to have any targeted approach to environmental impacts, notable airport developments and compact detached developments on greenfield sites, where is the green space and restoration here

Air Quality, Transport and Urban Development portfolio comments:

No access to public transport in rural areas except from district council rates these should not be included in rural rates through ecan

Regional and Strategic Leadership portfolio comments:

Stick to the ecan remit. Education guidance to education department accepted but not your responsibility to engage with this sector
