The affordability of maintaining public services is undermined in the long-term by permissive changes of land-use (ie. opening new land for development), and restrictions on redeveloping existing land (ie. building envelopes, restrictions on mulitiplex residential development, set back rules etc.) I realise that this does not sit in the eCan jurisdiction, but only through the whanaungatanga of working collaboratively between many regional, local and national agencies can we achieve lasting change in these areas. We need more liveable cities and towns that do not rely so heavily on expensive, low density infrastructure.
