Water and Land portfolio comments:

Clean water is fundamental to healthy life. Pollution of aquifers can take many years to show up and much longer still to clean up. Due to the elevated incidence of bowel cancer in Canterbury and recognition that this is likely due to exposure to nitrate I would like to see the allowed level of nitrate in drinking water reduced to 1mg/L. I believe this allowed level change is coming to Aotearoa and ECan should recognise this trend and prepare for it, hence my support for the prioritisation of protection and improvement of freshwater in the LTP.

I ask that the public be granted the opportunity to be heard on any decision made by elected representatives, or any delegated authority, that has significant implications for public health.

Biodiversity and Biosecurity portfolio comments:

Maintaining biodiversity is critical to the success of our food growing systems as well as to the protection of our whakapapa. Therefore I support the focus on regeneration of the natural environment in the LTP, particularly the Me Uru Rakau programme. I also support the expansion of the Enviroschools programme, the contestable fund for supporting local environmental projects and the braided river revival programme. Braided rivers are rare globally and Canterbury's unique instances of this iconic ecosystem deserve strong protection and restoration.

Climate Change and Community Resilience portfolio comments:

Climate change has become an urgent existential threat to our life support systems. We must take strong immediate actions to halt and reverse the rise in greenhouse gases and minimise Canterbury's contribution to them.

Air Quality, Transport and Urban Development portfolio comments:

Public transport is key to the reduction in transport emissions. I want to see more low emission buses and would also like to see the completion of the MyWay trial in Timaru. This is a valuable experiment and could lead to a more efficient public transport service in the long term. Children's fares on public transport should be extended to at least 18 year olds and preferably to all tertiary students. It's at this age that lifetime habits are set and ideally that should be a preference for public transport.

Regional and Strategic Leadership portfolio comments:

I support increased data collection and compliance monitoring. We need to increase understanding of the severity of the threats we face from climate change, freshwater pollution and biodiversity decline and better quantitative knowledge of the changes we have already experienced will be key to convincing people of the severity of the situation and underpinning action.

I don't agree with the principle of a UAGC because it is a regressive charge and affects the owners of low value properties more than those of higher value properties. I would prefer a charge that is proportional for properties below the median value and fixed above the median value. This would lower the burden for those probably least able to pay it and not unduly increase the rates for high value rural properties.

I would not support long term borrowing that could shift the burden of paying for spending onto future generations of rate payers, but short term borrowing could be used to reduce the increase in rates in years 1 and 2 by shifting some of the increase to subsequent years.
