Public Transport is very lacking in Selwyn District generally and seems to be almost entirely aimed at getting people to Christchurch and back. In keeping with coordination of regional/subregional objectives, I think that there should be more transport into and out of Rolleston (for access to shopping, dentists, audiologists, swimming pool, fitness centres etc) and Lincoln (access to university). This could also improve utilisation of bus services from Rolleston and Lincoln to Christchurch. At the moment the very limited Southbridge option (87) is used almost exclusively by schoolchildren as that is the only user base for which the current schedule is suited.
