#### Water and Land portfolio comments:

LTP page 6 acknowledges differences around the table but states "there is agreement we all want good quality freshwater". I support Ecan to take much bolder steps (particularly with the farming sector) to ensure we achieve this. River ecology monitoring should be included as invertebrate and fish life from my observations appear to be in serious decline.

## **Biodiversity and Biosecurity portfolio comments:**

Our biodiversity is being seriously threatened, particularly by current farming practices in Canterbury. I support Ecan to take much bolder steps to address this.

### Climate Change and Community Resilience portfolio comments:

I strongly support Ecan having a strong climate change voice at a national, regional, and local level.

### Air Quality, Transport and Urban Development portfolio comments:

I strongly support Ecan's efforts to transform the public transport network, with improved bus services and the move to low/zero emission buses. The public transport system needs to much more innovative, and Ecan needs to plan now for future transport corridors. Ecan needs to plan and activate good rail passenger services and consider initiatives such as trackless trams (rubber wheeled - used on roads and corridors in Europe and China). Coastal shipping also needs to be considered by Ecan - for passengers as well as freight.
