I think Option 1 is a genuine attempt to try to address the crises we face around climate change and biodiversity loss, while balancing the costs to ratepayers. However, the truth is we need to go much further than option 1 and the sooner we take action the more likely we are to change the course of the current trajectory and the cheaper it will be as well. We can't dodge these problems, we can't leave them for our children to solve. Our past decisions have caught up on this and we need to take urgent action to address land use, freshwater quality, biodiversity and carbon emissions.

Water and Land portfolio comments:

I believe it is the right of every child in Canterbury to be able to swim in their local river and to gather kai from their environment. At the moment, there are very few freshwater rivers and lakes we can swim in near Christchurch and I worry whether kai moana is safe to eat. I know land use change and freshwater quality are gnarly issues. It will take some big changes and some big investment to solve and I look forward to seeing how the new Freshwater regulations will make a difference. I support Option 1 but would like to see this go even further. I want changes to happen within a generation not 100 years.

Biodiversity and Biosecurity portfolio comments:

I support the extension of Me Uru Rakau, additional funding for pest control, a the contestable fund for community environment projects, additional funding for environmental education, expansion of the Enviroschools programme, more funding for wetland restoration and protection of our braided rivers. I particularly support investment in Pest Free Banks Peninsula. Habitat restoration and predator control are key to bringing back our native birds, lizards and invertebrates and we will see a spillover to Christchurch City. It will also provide a model for the wider Canterbury region. Nature-based solutions will be key to our response to climate change and ECAN has the opportunity and the responsibility to take a leadership role for Canterbury.

Climate Change and Community Resilience portfolio comments:

Yes I support the proposed works in Option 1 and would argue that we need to invest more funding in into this area. We are already seeing the effects of climate change now and we need to take urgent and meaningful action rather than incremental change.

Air Quality, Transport and Urban Development portfolio comments:

In an effort to reduce our household carbon emissions, I have been using the public bus service. And I have to say it needs to be a lot better than it is. The bus only goes every 30 mins and it is frequently late. It takes twice the time as driving and it is no cheaper than taking a car. Public transport has a crucial role supporting those with few transport options. But we need to think of those who do have transport options, who can choose to jump in their car instead. It is going to take a lot of effort to change behaviour, we are a car culture. Public transport needs to be so easy and affordable people want to take the bus. Buses every 15 mins, free fares, more routes. Really excited by the My Way Trial in Timaru.
