I strongly support Option 1!! It would be a great shame to have to settle for Option 2. I agree with your understanding that the community is calling for faster, more urgent action and strongly support option 1 and think it is a small price to pay for all the added benefits over option 2. I would like to see the positive, proactive changes at a scale at least as great as Option 1 and would be willing to pay even for more.

I really like the Contestable Community and Enviroschools fund. I definitely don't think the extra Enviroschools funding should be dropped as there is so much demand for it and it is crucial to the future of our region to be educating our young people. They also have some influence over their families perspectives.

I also support the investment in compliance officers to ensure that all businesses, organisations, groups and individuals are adhering to the regulations that are in place for the effective management of our environment.

I wonder at the biodiversity strategy having a bit more focus on land use, and particularly land use change that adversely effects biodiversity, as well as pest management and climate change as habitat loss is often the primary challenge faced by biodiversity (e.g. all the reports coming out of the UN Convention on Biological Diversity) but often gets less focus than some of the other more popular challenges like pests and climate change.

I believe Biodiversity consciousness should be mainstreamed across all the work that ECan does.

#### Water and Land portfolio comments:

Re the active regeneration of the natural environment and tree planting programme: I agree this is important but care should be taken with which species are planted and natives prioritised e.g. not lots of pine trees that can cause massive land subsidence issues when felled and contribute to wilding pine issues.

## Climate Change and Community Resilience portfolio comments:

RE flood protection and infrastructure: I support eco-friendly options, not hard infrastructure. I also don't think millions should be spent protecting a small number of coastal or river plain houses that will be unsustainable to live in in the next few decades with sea level rise.

## Air Quality, Transport and Urban Development portfolio comments:

I would like to see the trial MyWay in Timaru carried through to completion and implementing at a larger scale if data show that to be a good approach to the current public transport options.

I also think their should be incentives for people to switch to electric transport options for both public and private use - it's the obvious low hanging fruit for reduction in urban carbon emissions (as shown by the Climate Change Commission report).

I also wonder about focussing on people in the transition phase from school or university to working in terms of incentives for using public transport. They are more likely to when they are younger because it is free or perhaps they can't afford cars but if you can get them to continue using public transport as they transition to work (e.g. by free fares for the first year they are working or another strategy) then even when they are able to afford private vehicles they may be more likely to have formed a habit of using public transport.

I strongly support the development of safe (particularly separated) cycleways.
