As a member of the Christchurch Biosecurity Advisory Group I am committed to the control of unwanted invasive pests and weeds on Banks Peninsula also including the growth of biodiversity.

I support the Council's strong emphasis on biodiversity and biosecurity in the LTP.

The Council's has shown support, leadership and commitment in achieving pest and weed control on Banks Peninsula, with growing understanding of biodiversity.

My concern is the cost of biodiversity to the landowners on Banks Peninsula.

Banks Peninsula is unique with its growing biodiversity and with time will continue to improve.

Banks Peninsula is the holiday and play ground of the people of Christchurch.

I feel the burden of this cost should be shared by the great area of Christchurch as the growth will be to the advantage of ratepayers in Christchurch for their enjoyment and pleasure.

The targeted rate for biodiversity to land owners on Banks Peninsula be reduced to reflect the benefit for the people of Christchurch, as the current funding arrangement will place a significant additional financial burden on landowners.
