SUBMISSION REGARDING DRAFT LONG TERM PLAN 2021-31

The Akaroa Ratepayers and Residents Association is an Incorporated Society that has been established to promote the interest and wellbeing of the community in the Akaroa area. This submission is made on behalf of the members of this organisation, and we believe this also represents the general interests of the wider community.

This submission has been prepared by Harry Stronach, the President of the Society.

We wish to be heard in support of this submission.

Our Society looks at the activities of local government agencies such as Ecan, hoping to find common-sense decision making, efficient operations, and integrity. Sometimes we are disappointed.

In fact our Society has been rather critical of Ecan in recent years, and with good reason. In pre-Covid years we saw the activities of cruise ships caused widespread environmental degradation in Akaroa harbour, while the onslaught of tourists and buses on shore caused distress to the local community.

We also saw Ecan watched on, and inventing reasons why it could not act to control this situation. At the same time, it was obvious that the ships were operating in breach of Ecan's own Regional Coastal Plan.

We hope that we can now put that unfortunate situation behind us, and are pleased to see the commitment in the Draft LTP to review and upgrade the Regional Coastal Plan during the next 3 year period. We also note the considerable increase in the budget allowance for managing the coastal environment, and look forward to seeing that being applied with efficiency and dedication.

We also note that the Draft LTP contains considerable discussion on the subject of consultation, and the importance of communities, and resilience, and future generations. All this, and with a budget to match. While this reads well, our experiences with the consultation processes run by another Local Government entity, Christchurch City Council, have led to a rather cynical view on this subject.

In fact the widespread view in our community is that the consultation process run by CCC is frequently a sham, and their talk of strengthening communities and such-like is simply a smokescreen for council staff to pursue their own agendas, driven mainly by ideology and self-preservation. A very unfortunate situation indeed.

However Ecan is a rather different organisation, and we hope to see Ecan setting an example, and showing how consultation can be made truly meaningful. Your challenge is to put real meaning into the well-worded statements on this subject that are scattered throughout this Long Term Plan. We will certainly be doing our part.

There is one critical matter where Ecan can really affect the future of Akaroa, and that is the regulation of cruise ships. We believe that this subject is so important for the future of the community that any limitations and controls should be determined by taking a formal poll of all affected ratepayers. We look forward to making submissions on this subject in due course when the Coastal Plan is considered.

We also note the commitment in the LTP to the Pest Free Banks Peninsula project, and realise that this is a cooperative venture with many other organisations also being involved. However, Ecan will clearly be one of the lead actors as this drama plays out, and we will be looking for Ecan to put in the exceptional performance that we are sure it is capable of.
