I see more value in Option 1 than Option 2. However, I personally believe we need even further acceleration of action to compensate for the scale of human-induced environmental degradation and disturbance which we face. My personal view is I would happily provide further funding towards this in the interest of restoring our whenua

It is important that we hear what you would like to keep in the plan, what you think should be removed, and anything that you think we have missed?

I would love to see a move towards the eventually "re-gifting" of flood plain land back into connection with our braided awa. Our east coast braided rivers are of international ecological significance and have been intensively modified in many areas.

I'm skeptical of coastal hazard and flood protection works where they halt the natural geomorphological changes that are already underway. The detail of how each specific project ties in with naturally dynamic processes should not contribute further to modifying ecosystems.

I would love to see more direct plans to restore the full extent of pre-European freshwater biodiversity (e.g. reducing the ability of our native fish and invertebrate species to thrive without competing for food resources or predation). The disconnect between promoting game fisheries (and exploitation of whitebait) and seeking to restore the health of our waterways is always striking.

Perhaps I've missed it but there doesn't seem to be any mention of changes to consents granted for resources that are used for commercial gain. Acquifer abstraction for water bottling comes to mind which has been a major source of contention for some years. Seems like a missed opportunity to take a stand and at least acknowledge the public's concerns, if not propose alternative funding mechanisms. That said, I'm very aware of the fact that water abstraction for water bottling is generally much less environmentally damaging than equivalent use for agriculture....so I'm not ideologically opposed to these types of consents.

Investing in stormwater treatment initiatives at a scale that is proportional enough to actually achieve environmental quality outcomes. Efforts to provide stormwater treatment are often localised and of minimal effectiveness to actually make a significant enough difference. New developments have targets to meet, but there are almost no incentives to an existing homeowner to improve the effect the negative impact they have on their surrounding watercourses. For years it feels like minimal advertising and awareness are the only steps that have been taken that are relevant to the average homeowner. Perhaps incentivising higher levels of stormwater treatment provision at new sites than what current constraints require (i.e. via rates rebates). Retrofitting existing properties to achieve reduced levels of environmental harm via stormwater is expensive which will almost always result in the beneficial options never being selected.

I'm very aware of the volume of rubbish which ends up in the Otakaro River, and fly-tipped in our braided rivers. I would love to see localised diversion of this rubbish from our watercourses by changing the way we procure and specify stormwater infrastructure. Living in Burwood I regularly spend time on the Otakaro River, and last year we drifted past a pied shag (Karuhiruhi) in the water that had slowly starved to death from getting trapped in a plastic milk bottle lid ring. We can do better!!!
