Option 1: statutory work, prior commitments and accelerating key initiatives

It is important that we hear what you would like to keep in the plan, what you think should be removed, and anything that you think we have missed?

I support Option 1. I congratulate Environment Canterbury for being bold, stepping outside its comfort zone and proposing a significant rate increase to get the job done.

I feel that recent changes to the Public Transport System are detrimental to those who are visually challenged and am disappointed that there appears to have been no prior consultation before the changes were implemented.

Proposed changes in the PT network for the Selwyn region are not bold enough. Selwyn is the fastest or second fastest growing region in New Zealand and Ecan is missing to bus (so to speak) by not enhancing the provision of PT in Selwyn to match the population growth.

The two zone fare in Selwyn to Christchurch (and indeed Lincoln to Prebbleton) is a significant impediment to PT users and usage in Selwyn. Implement a one fare zone and increase the PT targeted rate to fund this.

BTW the format of the online consultation document is terrible. It made it very had to read on a computer screen.

Climate Change and Community Resilience portfolio comments:

I support the provision for a contestable fund to support work by community groups for local environmental projects.

I support the provision to increase the capacity to deliver the Enviroschools programme to the 40+ schools on the waiting list, as well as enhance the wider environmental education programmes.

Air Quality, Transport and Urban Development portfolio comments:

Public Transport:

An enhanced public transport system is vital for reducing emissions. However recent changes have not enhanced my experience with the current service.

The Teal coloured buses are a disaster for me as a visually disabled person. I can identify a "Yellow" bus at 4 times further than a Teal bus, I can identify a "Yellow" bus at 8 times further than I can read the digital route board on a Teal bus.

This makes identifying and catching a Selwyn bound bus on Main South Road or Riccarton Road significantly harder than it was before. This is a significant disincentive for using the bus service.

The fare zones need urgent rationalisation. Many Selwyn residents tell me that the two zone charge from Lincoln or Rolleston to Christchurch discourages them from taking the bus.

When weighing up the travel time and fare charged they prefer their private vehicle. An urgent reduction in fares to a single zone for (at least eastern) Selwyn residents traveling to and from Christchurch would significantly increase patronage. This should be funded by increasing the Selwyn PT targeted rate.

The MyWay by Metro trial in Timaru should be continued and consideration be given also to trialing this in Rolleston.

Bus route planning should be improved.

If bus routes in new large subdivisions do not occur as the subdivision is developed that we, Ecan and community, are missing the opportunity to encourate new residents to use buses.

Introducing bus routes 5 - 10 years are subdivision development is simply too late. Residents have habitualised themselves into car use and are much harder to pry out of their cars and back onto public transport.

WE NEED A MINDSHIFT IN HOW AND WHEN WE IMPLEMENT NEW BUS ROUTES.

The point at which students, secondary and tertiary, pay the adult PT fare needs to be reviewed and raised. At the vary point in their lives that we need to be encouraging our youth to use public transport we double the fare - literally driving many of our youth out of PT into older more polluting less fuel efficient cars.

Consideration should be seriously given to allowing students in full time study (or the equivalent) up to the age of, say, 25 to access the youth fare for PT use.

Regional and Strategic Leadership portfolio comments:

I commend the role Environment Canterbury takes in regional leadership. t As the regional council Ecan performs a value role in coordinating and leading regional forums and committees with our Territorial Local Authorities (TLAs).

TLAs often are focused on their own rohe and lack to greater vision that Ecan can bring to discussion and debate.

Ecan performs a vital role in ensuring the largest TLA doesn't dominate and bully its smaller neighbours to the detriment of regional collaboration.
