## Air Quality, Transport and Urban Development portfolio comments:

Our Board wants to comment specifically on air quality.

We have been working with residents whose lives are affected by quarrying. They are affected by the closeness of quarrying to their residential homes and by poor air quality.

The most extreme example is the Roydon Quarry on the border of Templeton subdivision. While we acknowledge land use is a Council issue, we are bringing to your attention residents' concerns regarding air quality.

Incidentally WHHR Community Board attempted through the Christchurch District Plan, heard by the Independent Hearings Panel to achieve a setback of 500 metres. This was unsuccessful.

As quarrying is increasing in the west of Christchurch the problem with air quality will only increase. Many residents believe their health is being affected.

They have advised the Board that when they contact Ecan to ask for staff to monitor the air qualitythey either cannot get through or the person answering the phone will decline to monitor.

Our submission is that Ecan employ additional staff whose sole focus is monitoring and enforcement of air quality and any resource consent conditions related to air quality for that particular quarry. Any consent conditions are legally binding, but obviously if no one visits on complaints there is no enforcement.

We believe that additional staff should have as their sole role air quality. If they do not have this singular focus they will be diverted to other duties.

We also understand that Christchurch may be the sole city In NZ that has quarries so close to urban living.

Mike Mora and Helen Broughton were driven around a quarry area in late 2016 and you could see particles hanging in the air.

One resident has described the area as "the Wild West".

Certainly if Ecan does not change its approach to monitoring and enforcement why would this change? WE WOULD LIKE TO PRESENT IN PERSON.

We hope to present some incidents from residents who have tried to make contact with Ecan and failed to get an officer to investigate.

Please engage additional staff to focus on air quality.
