The current state of our rivers is a disgrace, and we need urgent action on how we manage our freshwater.

Dairy farming practices continue to contribute to the increasing degradation of our waterways, we need bold action to put our environment before profit. The costs we will continue to pay for short-term gain are not worth turning a blind-eye to this issue.

Nitrates in the water present a health-hazard[2], have decimated fish populations from indirect effects[3], and this is having a devastating impact on us and our ecosystems.

We need urgent and emergency action to address this issue.

If dairy farmers are already under-pressure and doing everything they can to address this issue, then perhaps we need to have careful public consultation about whether dairy farming practices are suitable for the Canterbury Region at all.

We need to acknowledge the mistakes that we have made in the past so that we can move forward with kaitiakitanga for our future generations and the environment.

Climate Change and Community Resilience portfolio comments:

Priorities for land-use change, restoration and sequestration

It has been shown on the Hinewai reserve that gorse can be used as an effective canopy species for growing natives. This can present as a perceived conflict with neighbouring pasture farmers as mismanagement and negligence of the land.

We need clear guidelines to address the differences in land-use, and to legitimise practices which will regenerate and restore natives.

Support from ECAN is vital for reforestation efforts using managed pioneer plants to support the growth of natives, as we continue to head towards a worldwide climate crisis.

Canterbury has a huge capacity to sequester carbon, but limited water reserves. According to the FAO, increased plant-cover keeps moisture in the soil and reduces erosion. [1]

We need incentives for land-use change along these lines to decrease erosion and improve carbon sequestration. Examples of land-use change include: plant-based agriculture, permaculture and rewilding of the land. These could all be accomplished with minimal irrigation if planned appropriately.

It also means, that any pest control of exotic plants and trees needs to be carefully considered against the cons of drying out the land by stripping it bare.

The natural carbon cycle of allowing trees and plant matter to decay on the land, would improve soil quality and increase the amount of organic carbon that can be sequestered in the soil. We need effective land management policies that reverse nutrient depletion in the soil.

Alternatives to how we manage the land to effectively capture carbon need to be considered in response to the current climate crisis.
