## Water and Land portfolio comments:

The devil is in the detail;

#### Biodiversity and Biosecurity portfolio comments:

This portfolio is a crucial one if we are to prevent massive extinctions of unique NZ biota. I therefor applaud the work indicated in the present LTP.

BRAIDED RIVERS.

A. Pest management on the braided rivers

With warming summers and more extreme weather the need to ensure an improvement in braided river flows is needed to save the several unique birds species that rely on these rivers to breed successfully. Therefore I support entirely the move to improve the natural values of these river-beds through clearing them of weediness that reduces the area of breeding braids and provide cover for predators.

I request the following action from ECan for inclusion in work plans arising from this LTP.

1. Add more plant pests to the Pest Management Strategy; TREE LUPIN (which once established doesn't wash away in floods) and RUSELL LUPINS should both be added as control species and the sale of Russell lupin seed in garden shops should be banned.

ECan may need to initiate the process for this species to be added to the National Plant Pest Accord. It certainly should be removed from the present permissive status it enjoys in Canterbury.

2. Neglected for over a century, and often abused, the money ECan is proposing to spend on "Restoration" of the Braided Rivers is a drop in a bucket, or the canal or irrigation channel, large though it seems. The NEEDS TO BE A NEW STRATEGY;

#### HERE'S MINE:

We all use water and it is free to everyone. However the public know we've abused this privilege and not it's time for retribution. Surely it is possible to create a WATER TRUST INTO WHICH A VERY SMALL REPARATION IS MADE FROM EVERYONE [BUT THE SMALLER THEIR TAKE THE SMALLER THEIR CONTRIBUTION]. This fund would then be used (eventually) to expand the present efforts from a few rivers to all the degraded, weedy and drying rivers and streams of Canterbury. This would. be a contestable fund to which those wishing to make a difference, as so many farmers have

demonstrated they can and will, could apply.

#### B. RETURNING TO OTHER ASPECTS OF PEST MANAGEMENT:

Exotic mammalian species are clearly a threat to both bird, reptiles and insects and prey constantly on the river-bed breeders. Trapping programmes have been proved to make a difference. Less cover would help but it needs to be a constant effort.

Beyond the braided river there are other Plant Pests:

- 3. There are other pests becoming more obvious that will thrive in a warming Canterbury; ST JOHN'S WORT is slowly making its way along the roadways of our region and doubtless not confining itself to these migration routes. Poisonous to stock, it has long been a major problem in Australia as it thrives in hot, dry conditions, but also tolerates frosts.
- 4. Briar is another exotic advancing northward from Otago where it has a real stronghold. Spread by birds like the chaffinch and blackbird it establishes in areas once occupied by matagourie and so will begin to reduce areas of hilly drylands still largely in their original state.

### HOW IS ECAN GOING TO ADVANCE PREDATOR-FREE NZ?

I encourage ECan to support the steps towards making Bank's Peninsula a predator free zone. And in anticipation of the probelems that may develop along the way there is a need for the tricky question of where DO CATS fit in this endeavour?

A first step towards being able to address this would be for ECan to work with other LGAs to establish a Regional approach to neutering, registering and micro-chipping pet pussies as an obvious action of the responsible cat owner. Just as this is now accepted for dogs. In Australia chipping and neutering cats has been mandatory for some years because it was recognised the danger roaming cats were to native birds and small mammals. Let's STOP PUSSIE-FOOTING around these loveable carnevores.

This is one of the greatest and most important role ECan has. I wish you well with achieving even the modest goals that are already in this LTP but clearly I see there is much more that needs to be done.

## Climate Change and Community Resilience portfolio comments:

I confine my comments here to the horrendous effects that the upsurge in ownership of four-wheel vehicles, and their uncontrolled access to just about everywhere is having on our places of recreation and quiet reflection; our beaches, our river-beds and hill country.

Attempts were made early this century to control this growing problem but a visit to Ashworth Beach is enough to show that even an area that is supposed to be controlled has been damaged beyond reclamation.

Damage from the continuation of their uncontrolled access and irresponsible use will exacerbate the effects of sea level rise, increased storminess etc.
