Water and Land portfolio comments:

ECan needs to do more on monitoring and enforcement. The permissable level for nitrate levels must be lowered to the safe level of 0.87mg/l in accordance with the Danish study. ECan needs to take a stronger stance to ensure the necessary leglislation changes by central government.

Biodiversity and Biosecurity portfolio comments:

I would like to see more funding for increasing biodiversity.

Climate Change and Community Resilience portfolio comments:

I support more funding for climate education. Education must have an emphasis on collective action and systemic change. I would like ECan to trial a Te Tiriti compliant citizens' assembly to help address our climate response.
