The society agrees with the establishment of the regional targeted rate for Regional parks and that the rate collected can be used on any of the parks in the region. Up until now the Tekapo park has only had rates from Timaru and Mackenzie and has not had the funds to allow for any capital works to be carried out. The park has relied upon the society to provide capital recreational activities such as Toilets, carparks, picnic areas, dog park, pump park, disc golf and walking and biking tracks. The proposed tartgeted rate appears to increase for households in timaru and the mackenzie from around 70c to over \$10. We would expect to se some significant capital works carried out in Tekapo. The society also considers that more funding is required for pest control in the park and supports a predator fence around the park to control rabbits and wallaby to allow for significant native planting and restoration going forward.
