As part of water management, there's no commitment to review loopholes in the law that allow polluters to get away with it, and water bottling companies to exploit our precious resource.

Also missing is a clear direction around waste management, beyond adding to landfill. Completely

new processes (some of them tried and tested overseas) need to be created and implemented, so that we transform our waste into something useful and stop contaminating land.

Water and land portfolios (my further comments)

The work to be done in this area is urgent and something that the vast majority of New Zealanders wants to see happen URGENTLY.

In regards to water specifically, Canterbury is on the brink of losing its water security and the collapse of several ecosystems if bold action is not taken swiftly and without mercy or servitude towards corporate interests.

Specifically, E-Can needs to stop approving consents for water bottling and needs to represent the interests of Cantabrians by lobbying for the closing of the legal loophole that currently allows water bottling plants to access our pristine water at alarming levels, for no gain (no dollar figure could ever justify these consents to be authorised and this practice needs to be banned completely).

Also, the consent process needs to change, so that ALL consents affecting water need to be transparent and require public notification. The recent consent by MHV water cooperative to irrigate 56,000 hectares of private farmland for the next 10 years and dump alarming levels of nitrates which are responsible for the calamitous state of our waterways (all of this without having to submit a contingency plan, should it fail to comply). My hope is that the right thing is done and the consent is denied. E-Can keeps violating the population's trust and the values it's designed to honour and defend in action, on behalf of the people of Christchurch

Obviously, most New Zealanders want bold action taken, using our tax and rates dollars. And the work proposed in option 1 is the bare minimum considering the challenges we face as a community.

Here's what's unacceptable: for our rates to be funding environmental harm perpetrated by large corporations and farming conglomerates. And for our rates to pick up the clean up bill while these organisations collect profit and call it economic growth and job creation.

The population of Christchurch want bold action to protect their interests. And this is not about division. It's about meaningful change, and that can't happen while we continue to give permission to conduct business as usual.

In your draft plan you talk about a balancing act of sorts, mentioning economic wellbeing as one of the things we seem to have to make environmental sacrifices over. This is the wrong place to think and act from.

This premise has been proven to be a dangerous misconception of what's available, possible and proven. And sustainable economies are demonstrated in scandinavian countries, the Netherlands and other communities around the world.
