I am very concerned about the issue of nitrates in water. I would like nitrate polluters to pay heavily to address these issues, and I would like permissible nitrate levels reduced to Danish study amounts of 0.87 mg/l, and Ecan to take much stronger steps in changing rules, lobbying central govt, and monitoring and enforcement. Public transport needs to be drastically improved - more frequent services, more coverage, lower fares, ideally together with a social marketing campaign aimed at behaviour change. Cycling infrastructure should also be prioritised.
