In my case the proposed rate rise is 28.5% for option 1. No other enterprise except Local Body Authorities like ECAN has apparently unlimited power to increase revenue at the stroke of a pen. Businesses that tried such exorbitant price increases would soon fail. Unfortunately ECAN apparently has a free hand to charge what they like with no accountability.

ECAN needs to work a lot harder to reduce costs and so limit rate increases To the rate of inflation. Options 1 and 2 target the rural community because we don't have the voting numbers to get rid of profligate councillors but we end up doing the paying.

If you must have more money, get it by increasing the UAGC so that all rate payers equally carry the load, and can vote appropriately at the next elections if they don't like it.
