Much of the indigenous biodiversity of lowland Canterbury is in big trouble. We should be focused on preventing further harm to the remaining remnants of indigenous biodiversity in lowland Canterbury. I support the need for big and bold actions to improve our environment, but I worry that our desire to rush in and fix things fast with feel-good community actions will to do more damage than good. Community tree planting, and low-cost contractor maintenance of these sites, has certainly caused more harm than benefit to biodiversity in some places, by polluting the local genetics with inappropriate plantings, introducing weeds and pests, and harming local biodiversity with herbicides and line trimmers. (For more details, Miles Giller wrote an excellent article in a recent issue of the Canterbury Botanical Society Journal on the threats that plantings post to Canterbury's indigenous flora.) Local eco-sourcing of plantings is absolutely essential, not a nice-to-have, and when not available, planting should be delayed. Natural regeneration is *much* better for biodiversity than planting, and should always be the preferred option wherever there are local seed sources (eg all of Banks Peninsula). I hope that is the case for Me Uru Rākau. We need to be smart and think long-term when planning actions aimed at improving Canterbury's biodiversity.

Also, we need to get our region's carbon emissions down fast. I hope ECan's next ten-years are laser focused on that priority. Now is the time.
