I support the enduring priorities, transformational opportunities, values and operating principles. I think it's important to understand:

"Taking into account cultural, social, economic and environmental wellbeing" in light of environmental wellbeing being the basis for cultural, social, and economic well-being now and into the future. This means that environmental well-being needs should not be weighed up or 'balanced' against current economic returns in a way that enables further degradation of the environment. All our human well-being needs must be attended to in ways that are consistent with and supportive of sustaining and restoring the natural environment. They also need to be attended to in ways that take into account equity, so that everyone's needs are met well.

I strongly support ECAN's declaration of a Climate Emergency, and want you to act strongly and quickly in all ways possible to mitigate it and to embark on the transformations needed to provide for a future low-emissions, climate-challenged society.

The cultural, social and economic costs of climate and biodiversity instability are already significant, will become significantly greater, and without major efforts worldwide, will become catastrophic. The costs of insufficient action so large, that they justify major investments in mitigation and adaption now.

Water and Land portfolio comments:

Strong and rapid action to protect waterways and groundwater. This includes changes to the plan or any regulations to ensure the public can be heard on any decision affecting public health or the natural environment. No consents should be granted for activities that may endanger these, at least until the public has been well-informed, and had the opportunity to be heard. The protection of the natural environment and public health (especially climate stability, widespread biodiversity, and clean water, air, and soil) take precedence over private economic interests. For instance, no more consents should not be granted for activities that will continue or increase nitrate leaching to groundwaters and waterways.

Fertile and relatively uncontaminated soils must be protected from degradation, contamination, and from excessive encroachment of exotic plantation forestry. This would require significant support for discovering and propagating restorative agricultural practices.

Biodiversity and Biosecurity portfolio comments:

Biodiversity is an important basis for sustainable environment and society and economy. Biodiversity loss and loss of habitat need to be strongly defended against.

Climate Change and Community Resilience portfolio comments:

In addition to transport, urban design, transport, land-use mentioned in other answers, there needs to be a good education programme so that people understand the need for strong action and change.

Air Quality, Transport and Urban Development portfolio comments:

In light of the Climate Emergency, and the need to get GHG emissions down significantly within the early part of this LTP term, and down to much less than half by the end of it, there is a need for greater breadth, investment, and speed.

Urban development for future population expansion and movement away from climate-change affected areas must be planned for well in advance of emergencies that will come. Housing, community, and economic activity, and transport should be strongly integrated for effectiveness and for consistency with a very low emissions future.

Markets alone are unlikely to be able to do this.

It is important that ECAN participate in strong forward planning and actions to enable and support this.

Strong and rapid action to ensure that most people have access to safe, accessible, low-emissions public transport, as well as safe practical active transport routes so that people have suitable alternatives to personal cars. While some revenue may be able to be gathered from public transport fares, it's important that public transport be more affordable as well as more effective. I support significant reduction in public transport fares for young people, for community service cardholders, and more widely to regular commuters to make it easier and more likely that people will reduce private car use.

Regional and local routes for active transport and for e-scooters and e-bikes must be provided so that these can become the primary modes for most people most for most trips. These need to be easy to find, well signposted, safe (separated from motor traffic), pleasant, and supported with other infrastructure such as secure parking, shelters etc.

The revenue required should be sourced in a way that does not place more costs on those least able to afford it; I would support a more progressive rating scheme, accessing more funding from payments by polluters, from NZTA, and other central government funding. More of the rating should come from progressive general rating based on property values, less from fixed UAGC, in order to improve equitability. Consider additional changes to the rating schemes to increase rating on land that is used for activities that make a profit from activities that create environmental or public health harms (where there are permitted at all).
