What do you feel are the significant challenges and opportunities we face?

There are significant regulatory headwinds facing all regional councils. Environment Canterbury has invested significantly in sub regional plans to give effect to NPS FM17 and we strongly recommend further work is done to ascertain the ability to push back the 2024 notification requirements where subregional plans are already in place and already on a pathway to achieving the new NPS FM 20 targets. Prioritising rework that will be expensive and add very little value in terms of improving environmental outcomes is strongly opposed by MHV Water

We do not support either option and believe ECan have sufficiently investigated the extent of need for the statutory requirements and as such the costs could be reduced. We believe there are also considerable other costs which could be controlled as opposed to just looking to increase revenue (rates).
