## Draft Long Term Plan Submission from Te Taumutu Rūnanga

- 1. Te Taumutu Rūnanga wish to acknowledge the significant working relationship and partnership between the Council and the Rūnanga at both a Governance and operational level and we look forward to continuing in working together for the benefit of our region
- 2. Te Taumutu Rūnanga support funding option 1 (Councils preferred option)
- 3. We recognise and support the Councils continued investment in Regional & Strategic Leadership commitment to working with Ngāi Tahu and on Ngāi Tahu representation on Council and the invaluable mahi by the Tuia Team.
- 4. We recognise that significant engagement with Papatipu Rūnanga will be needed to implement Te Mana o te Wai and the Essential Freshwater package. Te Taumutu Rūnanga supports any funding and resourcing to enable this, including for the development and implementation of the Mātauranga Māori monitoring programme.
- 5. Te Taumutu Rūnanga recognises and supports resourcing and funding to deliver mahinga kai outcomes, as outlined in the CWMS targets.
- 6. We acknowledge the support and funding the Council have given to the Pest Free Banks Peninsula Programme, of which Te Taumutu Rūnanga are a party of. We would support further funding to achieve the vision of a Pest Free Banks Peninsula and Kaitorete.
