# The Trust's submission



We thank Environment Canterbury for their ongoing support of the Estuary Trust's work.

#### We support Option 1

"There is a pressing need to see further improvements in water quality, manage significant pests, restore degraded habitats, respond to climate change, and deliver a sustainable public transport network".

# 1. Estuary Trust Annual Funding

The Estuary Trust gratefully acknowledges the annual grant from Environment Canterbury of \$20,000 to assist the Trust to meet the vision of a health estuary. However, this grant has been at the same level for the past ten years. In that time we have a major increase in community expectations, attendances at community events, organisational advice and support for our river and catchment networks, and the need to provide more organisational effort for our growing wetland restoration programmes.

The annual grant is used by the Trust to manage activities such as the annual Farewell to the Godwits event, the annual Mother of All Clean Ups, the annual Estuary Fest, scientific research, public presentations, and to initiate and plan ecological restoration programmes.

Because of the growing demands and costs associated with those activities, the Estuary Trust requests that **the annual grant be increased to \$26,000**.

The Trust Board looks forward to continuing our work as well as working with the Regional Council in the delivery of Te Mana o te Wai and all estuarine and coastal planning initiatives.

### 2. Improve stormwater quality including sediment controls

#### 3. Assist with public education programmes

We ask that Environment Canterbury promote awareness of actions that people can take to stop contaminants from entering stormwater.

The Trust recognises that the recovery of our local streams, rivers and estuaries depends on an environmentally literate and engaged community. Education is a strategy used by the Trust in accomplishing our mission and has been a core component of our management planning.

#### 4. Nutrient and contaminant reduction

We request that levels of nitrates and other contaminants in waterways are reduced to protect human and ecological health.

This would first include funding for the investigation of where excessive nutrients are coming from (including outside of city catchments). We suggest analysis of selected contaminants to determine spatial distribution of contamination.

We request further funding to stop contaminants of emerging concern, such as groundwater nitrate levels and microplastics, which ultimately contaminate the Estuary. This would be informed by the first point – the source of the contaminants.

# 5. Collect and analyse water quality data from drains near the wastewater treatment ponds

We are concerned about the discharges from drains that flow directly into the Estuary.

Although the drains may be a City Council responsibility we urge Environment Canterbury to monitor these discharges and to react accordingly so as to reduce contamination of the Estuary.

### 6. Acquire flow information for Linwood Canal

Linwood Canal is an open drain carrying stormwater to the Estuary. Again, the drain may be a City Council responsibility, but we ask that the regional council monitors this water body and if necessary takes action to ensure it is not polluting the Estuary.

#### 7. Enhanced water quality data collection in the marine environment

The Trust is committed to science-based decision making. We would like to see water quality data and other scientific monitoring and reporting continue within the Estuary, but also would encourage **enhanced data collection in the marine environment** to inform the Regional Coastal Environment Plan. The state of our marine habitats, in part, will reflect the effects of land use practices, which also impact on the Estuary.

Gaining a good understanding of those impacts will help inform policies to improve the quality of all water environments, from mountains to sea.

We highly value the species that are present in the coastal environment and migrate into the estuary, including fish, birds and mammals, and therefore support the funding of the Coastal Environment Plan which will update policies to protect such species.

#### 8. Pest control

We request that funding be allocated for pest control around the Estuary. In our view there is an increasing number of mustelids around the edge of the Estuary, these are a significant threat to indigenous birdlife.

There are also large numbers of Canada geese in the Christchurch environment, these numbers restrict habitat for indigenous wildlife.

Finally, there is a risk of further habitat destruction for plant pests. We urge Environment Canterbury to initiate and prepare a pest control strategy for the Estuary.
