

Submission to Environment Canterbury

Te Pae Tawhiti 2021 – 2031

Our Anglican church group is supportive of the stewardship responsibilities that are exercised through our community governance organisations.

We agree with the role expressed on page 19 of the Environment Canterbury's 10 Year Plan, Te Pae Tawhiti 2021 -2031. "...implementing opportunities to deliver on future stewardship of land and water using the regulatory and non-regulatory functions." We urge improvement to the goal of healthy waterways. Restraints and inaction have not served the environment well. We support the increased rates funding for monitoring education, enforcement and prosecution to achieve Te Mana o te Wai and make improvements to our fresh water.

We view the deterioration of Lake Ellesmere and the Selwyn River with anger and grief. The iconic picnic spot, Coes Ford, is no longer safe for swimming.

Environment Canterbury needs to ensure that irrigation consents and replacement consents are open for public submission because nitrate levels endanger public health and the environment is adversely affected. (Refer Press 4 March, 2021).

We urge Environment Canterbury support for the Travis Wetland to which St Barnabas Church has sent work parties. Dean's Bush is a treasured remnant of native forest that should be a nucleus for the return of native birds to the surrounding area.

We would like to make verbal submissions to the Council.
