### 4.1. Hearing of submissions to the Long-Term Plan 2021-31

#### Purpose

1. To update Councillors about the hearing of submissions to the Draft Long Term Plan 2021-31, and provide Councillors with guidance about the hearing process.

#### Recommendations

That the Council:

1. receives this report on submissions to the Long-Term Plan 2021-31.
2. accepts the late submissions to the Long-Term Plan 2021-31, as listed in this report.

#### Background

2. Formal consultation on the draft Long-Term Plan was undertaken from 8 March to 11 April 2021. 1291 submissions were received with approximately 275 submitters indicating they would like to present their submission to the Council in person.

#### Late submissions and other submissions

3. 26 late submissions were received after 11 April 2021 (Please refer to these submissions listed in attachment 1).
4. Council is required to resolve to accept the late and other submissions.

#### The hearing

5. The hearing is the opportunity for submitters to present their submission to Council in person. Each submitter has been allocated 10 minutes for their presentation.
6. The hearing has been scheduled over four days:

- a. Tuesday 27 April commencing at 1.00pm
  - b. Wednesday 28 April at 9.00am
  - c. Tuesday 4 May at 9.00am
  - d. Wednesday 5 May at 9.00am
7. Councillors can ask submitters questions of clarification only (through the Chair), but cannot cross examine or debate the submissions. No decisions on the submissions presented at the hearing are made at this meeting.

## **Risk assessment and legal compliance**

### **Conflict of interest**

8. A conflict of interest can arise in either of two general ways:
  - where a Member stands to benefit from a matter before Council for consideration (whether personally; or through connections with other individuals or businesses with which the Member is involved) (“pecuniary interest”); and
  - where a Member holds a bias, or might be perceived to hold a bias, in relation to a matter that is before Council for consideration (“bias”).

### **Next steps**

9. Following the hearing of submissions, the Council will meet on Thursday 20 May 2021 to deliberate on all the submissions.
10. On 17 June 2021, the Council will meet to adopt the Long-Term Plan 2021-31 and set the rates for the 2021/22 financial year.
